Old Business:

- a. Reactions to the New Mass Schedule
  - Some folks have been missed – most likely relocated to Bangor, likely due to mid-morning time slot.
  - St. Helen's attendance up slightly.
  - 4pm, 8am, and 11am masses all show increases in attendance.
  - Parking being an issue-possible new parking plan including painted parking lines
- b. Refreshments after Masses January 3<sup>rd</sup> and 4<sup>th</sup>
  - OK attendance, those who stayed enjoyed themselves
  - St. Helen's was very positive
- c. Send-off for Sr. Barbara and Sheila

  - Father Joe has submitted list of issues to be checked out, water temperature in boiler has been reduced, savings will be computed at the end of the season.
